本校將於二零二零年十一月十六日透過「電子繳費系統」收取以下費用，煩請 貴家長細閱有關收費項目及繳費細則，選擇下列其中一個方法付款增值 貴子弟的智能卡戶口：

- 1) 支付寶香港 Alipay HK
 - 使用支付寶香港 Alipay HK 無須繳交行政費
 - 家長必須在手機上安裝支付寶香港 Alipay HK 手機程式，並使用 eClass Parent App 為學生戶口增值。
- 2) 電話／網上繳費靈
 - 請於收費總額上另加\$2.2 增值行政費
 - 本校的繳費靈商戶編號：9620，商戶名稱：順利天主教中學，賬單號碼：學生 6 位數字的註冊編號。
- 3) 到 Circle K 或華潤萬家 (VanGo) 便利店使用「櫃位賬單繳費服務」
 - 請於收費總額上另加\$3.4 增值行政費
 - 家長必須帶同學生手冊為學生戶口增值，並展示手冊第 28 頁的條碼予便利店店員以資識別。增值後請家長自行保存收據即可。

ePayment System Second Fee Collection

Our school will collect the following fees through the Student Smartcard (ePayment) System on the 16th November 2020. The list of fees to be collected and details of payment are given below. Parents may top up their balance by the following methods:

- 1) Through Alipay HK
 - There is no administration fee for using Alipay HK.
 - Parents must install the Alipay HK App on their smartphones and top up student’s account using eClass Parent App.
- 2) Through PPS (via phone/internet)
 - Please deposit an administration fee of \$2.2 on top of the total amount.
 - **The school account no. is 9620.**
- 3) By using the over-the-counter bill payment service available at Circle K or VanGO Convenience Stores
 - Please deposit an administration fee of \$3.4 on top of the total amount.
 - Parents need to bring along their children’s student handbook and provide the shop assistant with the barcode on P.28 of the student handbook when making a deposit. Parents can keep the receipt after crediting their account.
